

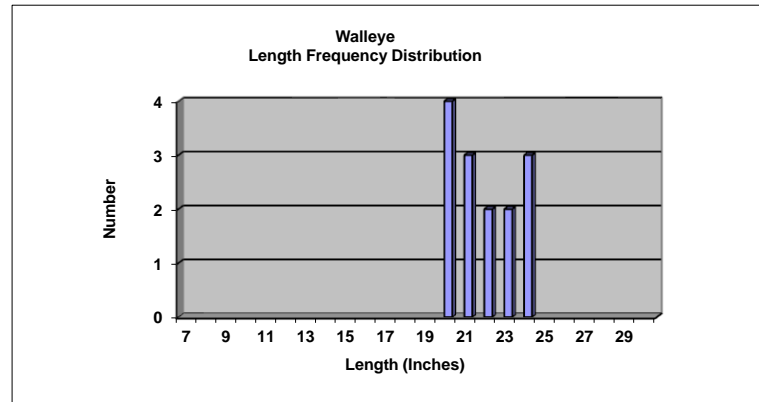


**WISCONSIN DNR
FISHERIES INFORMATION SHEET
HORSESHOE LAKE, WASHBURN COUNTY, 2014**

The WDNR surveyed Horseshoe Lake, Washburn County from April 29th through May 2nd 2014 to evaluate the walleye population. Horseshoe Lake is a 194 acre seepage lake and has a maximum depth of 21 feet. The fishery includes panfish, largemouth, northern pike and walleye. Horseshoe Lake has a low density remnant walleye population.

We are also conducting a creel (angler harvest) survey on Horseshoe Lake this year. Creel clerk Mycal Raleigh will count and interview anglers and examine their catch throughout the fishing season.

General Fishing Regulations for Horseshoe Lake, Washburn County, 2014

FISH SPECIES	OPEN SEASON	DAILY LIMIT	MINIMUM LENGTH
Walleye	May 03-March 01	5	15" MINIMUM
Largemouth Bass	May 03-March 01	5*	NO MINIMUM
Smallmouth Bass	June 21-March 01	5*	NO MINIMUM
Muskellunge	May 24-November 30	1	40" MINIMUM
Northern Pike	May 03-March 01	5	NO MINIMUM

*During harvest season for each species; you are allowed a daily bag limit of five largemouth or smallmouth bass in total.

This report is interim only; data and findings should not be considered final. Results of creel surveys should be available by June of the year following the survey.
